### **Grant items – See Attachment 2**

- **Grants 11/18:** Quotes for (a) extension of clubhouse on NE with changerooms and (b) just adding two shower rooms to gents toilets , changing one ladies toilet to a shower and converting latest ladies toilet to two toilets with an extra wall. Apply for a NSW Government Grant and/or seek ACC 50/50 deal.
- **Grants-06/19:** Successful - \$78,000 for Flooring Upgrade. Quotes being considered fall within grant.  
 IR: Need warranty information in writing particularly with respect to ensuring flooring over existing flooring does not void warranty.  
 IR: Emailed Rob of Affordable with queries.  
 IR: Checking other supply/quality options.  
 CL: We may need a layer of something between the existing flooring and the new flooring. CL to check this.  
 TC: Feedback from Les Dawson (MPTTA), Greg Bristowe (Croydon) and Claire Montgomery (various).
  - Tinsue (China) seems more durable than Taraflex (France, via Gerflor, guaranteed for 10 years) even though cheaper by close to 30%. Show no wear in 10-15years at very busy Chinese venues, so could be good for 20 years at AWTTA.
  - Check that the thicker (6/6.2mm) flooring normally used on concrete is suitable over the existing flooring. This might affect the bounce on the tables. May need to consider 4/4.8mm thickness normally used on wooden floors.
  - All recommend gluing flooring in place. One venue that didn't glue has movement issues. Another has it lift with a strong wind. Use professional as one done by working bee has to be lifted and re-done.
  - Ensure that it is professionally welded.
  - Regular cleaning is important – perhaps buy industrial floor cleaner as part of the package.
  - Store spare rolls upright with interleaved paper(?) as supplied otherwise there will be damage to the surface which makes it slippery.
