# • Spring Season update

Total of 81 players across four Divisions. Division 1 has 8 teams of 2 players, Division 2 has 10 teams of 3 players, Division 3 has 9 teams of 3 players and Division 4 has 4 teams of 2 players. Concern was expressed about the drop in numbers overall, but particularly for Division 4.

# • By-Laws update to cover Leading Players

lan Radley spoke to the proposed update, to include an additional By-Law to clarify leading player requirements, which was circulated to Committee members prior to the meeting.

Motion: That the following By-Law be added to Section 5: Player Eligibility:

#### 5.4 Leading Player

- 5.4.1 The Leading player for each Division for the season will be the player with the most Match wins for the season, excluding finals matches.
- 5.4.2 In the event there are two (2) or more players who are on the same Match wins, the player with the highest winning percentage will be deemed as the leading player.
- 5.4.3 If there is more than one (1) player with the most Match wins and the same winning percentage, then there will be joint Leading Players.

### • Sunday sessions roster / inviting groups
