### **President's Report**

### **Pennant Coordinator's Report**

The Pennant Coordinator's Report was presented by Ashley Harding. Key points noted were:

- There were 41 weeks of play, consisting of 118 teams and 325 players in four Divisions over three seasons. This represented an increase of 27 players compared to 2024.
- Details of season results, and other events held during the year are included in the President's Report.
- Thanks were extended to all players, fill-ins and to the Coordinators: Ashley Wurtz (Division 1), Cody Luton (Division 2), Chris Grealy (Division 3) and Emily Bollingmoore (Division 4).
- The Club Championships were held in October and the results were as follows:

Division 2: Angas Avery defeated Craig Salzke  
Division 1: Levi Geering defeated Andrew Lindner

Trophies will be presented to these players at the start of the next season in 2026.

- Next season will commence in early February, with the Grading Night scheduled for Wednesday 28 January 2026.

### **Treasurer's Report:**

The Treasurer's Report for the period 1 July 2024 to 30 June 2025 was presented by the Acting Treasurer, Janet Freer.

The Club continues to enjoy a strong financial position and is currently working towards having sufficient funds to contribute towards the proposed building plans, with the initial focus being on new changerooms and improved toilet facilities.

It was noted that major contributing income towards the Club's financial position are Pennant and Keenager player fees, Schools and Groups player fees, sponsorships, grants, interest and tournaments.

On the other hand, major operating expense items were stadium cleaning and waste management, electricity, replacement of air conditioners, and the AlburyCity loan repayment.

Non-Current Liability of \$19,500 is still owed to Albury City (Interest Free Loan over 10 years). Repaying annual instalments of \$6,500.
